1. This Invitation for Bids follows the General Procurement Notice for this Project that appeared in **UN Development Business**, issue no. **IDB 08-01/17 of January 3, 2017**.
2. The Government of Belize acting through the **Solid Waste Management Authority of the Ministry of Agriculture, Forestry, Fisheries, the Environment, Sustainable Development and Immigration** has received a loan from the Inter-American Development Bank toward the cost of the Solid Waste Management Project II, BL-L1021, and it intends to apply part of the proceeds of this loan to cover eligible payments under **Contract No. 10-2018/2019: Closure of Two “Open Dumpsites” and the Construction of Two “Transfer Station Facilities” for Dangriga and Belmopan** .
3. The **Solid Waste Management Authority of the Ministry of Agriculture, Forestry, Fisheries, the Environment, Sustainable Development and Immigration** now invites sealed bids from eligible and qualified bidders for **Contract No. 10-2018/2019: The Closure of Two “Open Dumpsites” and the Construction of Two “Transfer Station Facilities” for Dangriga and Belmopan**. The delivery/construction period is 10 months.
4. This procurement process requires bidders to have the following specific experience and/or capabilities:
 - experience in works of a similar nature and size (these shall include the construction of industrial type buildings with steel framed systems, earthworks including the construction of access roads and site drainage system or similar, for each of the last

- five (5)** years, and details of work under way or contractually committed; and clients who may be contacted for further information on those contracts;
- qualifications and experience of key site management and technical personnel proposed, including a Contract Manager (Project Manager) with at least 10 years' experience in the management and supervision of similar building and civil works, two Site Supervisors each with at least ten (10) years of proven experience in supervision of similar building and civil works;
 - audited (or renewed) financial statements of the bidder, such as profit and loss statements and auditor's reports for the past **five (5)** years;
 - The minimum amount of liquid assets and/or credit facilities net of other contractual commitments of the successful Bidder shall be BZ\$500,000.00 of which at least BZ\$200,000 must be in cash.

5. Bidding will be conducted through the **International Competitive Bidding (ICB)** procedures specified in the Inter-American Development Bank's *Policies for the Procurement of Goods and Works financed by the Inter-American Development Bank GN-2349-9*, and is open to all bidders from Eligible Source Countries as defined in the policies.

6. Interested eligible bidders may obtain further information from **Solid Waste Management Authority of the Ministry of Agriculture, Forestry, Fisheries, the Environment, Sustainable Development and Immigration**, at the address (1) below from **08:30 AM to 4:00PM Belize Local Time**.

7. A complete set of Bidding Documents may be obtained free of charge by interested bidders on the submission of a written request at the address (1) below.

8. Bids must be delivered to the address (1) below at or before **June 29, 2018 at 10:00AM Belize Local Time**. Electronic bidding shall not be permitted. Late bids will be rejected. Bids will be opened physically on **June 29, 2018 at 10:05 AM Belize Local Time** in the presence of the bidders' representatives who choose to attend in person at the address (2) listed below.

9. A **site visit** will be held at the Dangriga Dumpsite, 1 Mile Southern Highway, Stann Creek District on **Friday, June 1, 2018** starting at 9:00AM Belize Local Time followed by one at the Belmopan Dumpsite, situated on the East Side of the Hummingbird Highway, 3.5 Miles Southeast of the City of Belmopan, Cayo District starting at 1:00 PM Belize Local Time on the same date. A **pre bid meeting** will be held on **June 1, 2018** at the **Solid Waste Management Authority Conference Room** from 2:30 – 4:00 PM Belize Local Time for both sub-projects.

10. All bids shall be accompanied by a Bid Security of BZ \$20,000.00.
